NOTE:

- The examinations in certain discipline subjects like **Bengali, French, German, Physical Education, Sindhi, Statistics, Tamil Telugu, Accounting & Finance, Apparel Design and Construction, Arabic, Banking and Insurance, Buddhist Studies, Commercial Laws and Corporate, Entrepreneurship and Small Business, Human Resource Management, Modern Office Management, Sales Promotion and Sales Management, Tax Procedures and Practice** will be held only on one day i.e. 12th December, 2024 for Semester III, 16th December, 2024 for V Semester & 07th January, 2025 for Semester I. The candidates will be required to appear in their Second discipline subject on other day i.e. 18th December, 2024 for Semester V, 20th December, 2024 for Semester III & 10th January, 2025 for Semester I. For example, in the combination of **Bengali/Political Science** the examination of Political Science will be held 18th December, 2024 for Semester V, 20th December, 2024 for Semester III & 10th January, 2025 for Semester I and in the combination of **Economics/German** the examination of **Economics** will be held on 18th December, 2024 for Semester V, 20th December, 2024 for Semester III 10th January, 2025 for Semester I.
 - However, the examinations in some Discipline Subjects for each part have been scheduled for two days. Candidates will be examined strictly in **the alphabetical order of the subjects offered.** For example, in combination of **Economics/History**, the candidate should appear in Economics on 12 December, 2024 for Semester III, 16th December, 2024 for V Semester and on 07th January, 2025 for Semester I and in History on 18 December, 2024 for Semester V, 20 December 2024 for Semester III & 10 January, 2025 for Semester I. Similarly, in combination of **History/Political Science**, the candidate should appear in History on 12 December, 2024 for Semester III , 16 December, 2024 & 07th January, 2025 for Semester I and for Political Science, on 24th December, 2024 for Semester V, 27 December, 2024 for Semester III & on 14th January, 2025 for I Semester.
