- 2) This Final Merit list has been updated after the Candidates have edited their Application after declaration of Provisional Alphabetical Merit list.
- 3) The Admitting College/ Department will be responsible for verification of the documents related to Candidature Type/ Category/ Educational Qualification/ Defence/Minority/Orphan/Disability as is shown against the candidate's name in the Final Merit list.
- 4) Though E-verification of the document has been done, the Admitting College/ Institute/ Department should get original documents of the candidates verified minutely and matched with the documents uploaded by the Candidate.. If any discrepancy is observed the candidate be guided to edit the CAP application form before Round II.
- 5) In No case the Merit is to be violated.
- 6) All procedure detailed in the CAP Information Brochure is to be followed scrupulously. Subject specialization of the qualifying HSC Certificate examination is to be minutely scrutinized while confirming admission.
- 7) The marks on which Class/Grade and Degree has been awarded has to be considered for verifying the qualifying degree /Certificate marks.
- 8) Admitting Colleges/Department should check the qualifying marks and the subject specialization of the Candidate in the Qualifying degree/certificate.
- 9) Candidates and the Admitting Colleges and the Department should comply with the remarks shown in the column No.13 while admitting the candidate.
- 10) J&K Migrant Candidates should submit all their documents in self certified Manner along with CET and CAP Application form and the with the documents required for J&K Migrant Candidates to **Director, Higher Education, M.S. Central Building, Pune 411001**. the Proposals submitted by Candidates will be verified by the Expert committee, and if required the candidates will be called in person.
- 11) After verification at DHE the Final List of Candidates will be published on the course web page and the candidates will be allocated on the basis of Merit and Option in Round II of on Line Admission Round.
