Post Graduate Degree and Super Speciality Courses in all Govt. Medical Colleges of the State rescheduling of Admission and other fees and in accordance with the provision of NMC, New Delhi, the admission and other fees for admission on 50% seats of Degree and PG Degree courses of Private Medical Colleges and Deemed University will be same as rescheduled fees for Govt. Medical Colleges has been approved. In the light of above Deptt. of Health, Govt. of Bihar also provided the above seat matrix of Private Medical Colleges.

In this connection it is to inform also that against the above order of Health Deptt., Private Medical Colleges have filed appeal before the Hon'ble Supreme Court, New Delhi and Patna High Court, Patna.

Hence admission and other fees of Private Medical Colleges of Bihar will be subject to the final decision of apex court in the writ petition (civil) no.-646 of 2023 and other similar situated writ petition and the final decision of Patna High Court, Patna.
