**NEW STRUCTURE AND PATTERN OF QUESTIONS**

The structure and pattern of Questions has been changed for each theory paper of all PG Programmes under the Directorate of Distance Education, Tripura University from December 2012.

**The structure of each theory paper shall be as follows:**

40 (Forty) Multiple Choice Questions (MCQs)	1 X 40 = 40 Marks
04 (Four) Short Questions	2 X 04 = 08 Marks
04 (Four) Broad Questions	<u>8 X 04 = 32 Marks</u>
	<b>Total = 80 Marks</b>

(Excluding 20 Marks for Assignments)

- A. Booklet** There shall 40 (forty) Multiple Choice Questions (MCQs) each carrying 1 (one) mark.
- B.**
- i. There shall be 8 (eight) short note type brief questions (two from each Unit) out of which candidates are required to answer 4 (four) short questions selecting one from each Unit. Each question shall carry 2 (two) marks.
  - ii. And there shall be 8 (eight) broad questions (two from each Unit) out of which a candidate is required to answer 4 (four) questions selecting one from each Unit. Each question shall carry 8 (eight) marks.

Candidates will be required to write answers (four short type brief questions and four broad questions) within the Answer Script itself [strictly within the space allotted and word limit (not exceeding the maximum limit of 300 words for broad essay type questions)]. Candidates shall not be allowed to use any separate Loose Sheet.

**Time:**

- A. For Booklet (containing MCQs) time shall be 60 Minutes i.e. 01(One) Hour.  
B. For Short type Brief questions and Broad Questions time shall be 120 Minutes i.e. 02(Two) Hours.

**Total Time: 180 Minutes i.e. 03 (Three) Hours.**

Candidates will be provided a Booklet containing the MCQs which they are required to answer within a maximum time of 01 (one) hour. After 01 (one) hour, Candidates shall submit all OMR sheets and Question Booklet. The Question Paper (containing short type brief questions and broad essay type questions) and Blank Answer Scripts will then be supplied to the students, and they will be required to complete their answers in this part within 2 (two) hours.

**The pattern of Multiple Choice Questions (MCQs) shall be as follows:**

- a) Usual Multiple Choice;
- b) Matching;
- c) Assertion and Reasoning;
- d) True and False.
