Provided that candidates belonging to SC, ST & Category - I should produce an Income certificate issued by Jurisdictional Tahasildar as per the format prescribed by the Government. (This is for the purpose of processing eligibility of candidates to claim Government of India scholarship).

Income certificate should contain RD number and the certificate has to be issued in the name of the candidate.

EWS certificate and Arya Vyshya certificate (Form-G) should not be uploaded as Income Certificate.
