BACKGROUND

Government of India introduced the **Craftsmen Training Scheme (CTS)** in 1950 to ensure steady flow of skilled workers in different trades for the domestic industry with an aim to raise quantitatively and qualitatively the industrial production by systematic training, to reduce unemployment among the educated youth by providing them employable training, and to cultivate and nurture a technical and industrial attitude in the minds of the younger generation. This CTS courses are being implemented in **Industrial Training Institutes** all over the country.

OBJECTIVES OF CRAFTSMEN TRAINING SCHEME

- (i) To equip the human resource with appropriate skills required in the labour market
- (ii) To make the youth more productive by providing them employable skills to achieve wage benefit as well as self-employment
- (iii) To produce highly skilled craftsmen for the industry
- (iv) To ensure steady flow of skilled workers for industrial/ service sector
- (v) To raise the quality and quantity of industrial production by systematic training of potential workers






GOV'T INDUSTRIAL TRAINING INSTITUTES, MIZORAM

Industrial Training Institutes in Mizoram are all owned by State Government. There are 3 (three) ITI's run by **Department of Labour**, **Employment**, **Skill Development & Entrepreneurship**, (LESDE) namely-

- (1) **ITI Aizawl**, established in 1964 initially hosted by ITI Srikona, Assam until since 1975 when classes were started in Aizawl. Located at the ITI veng, the outskirt of Aizawl city. The locality is also named after this ITI. It is the oldest and biggest ITI in Mizoram, having 21 nos. of affiliated trades (NCVT/MCVT) and running 15- 21 trades every session.
- (2) **ITI Lunglei**, established in 2002 initially hosted by ITI Aizawl until 2005 when classes were started in its present Location. It is Located at Salem Veng, Lunglei, the outskirt of Lunglei City. It has been running 5 trades.
- (3) **ITI Siaha**, established in 2002 initially hosted by ITI Aizawl until 2005 when classes were started in its present location. ITI Siaha is located at Meisatla, Siaha, the outskirt of Siaha town. It is running 4 trades.

HOW TO APPLY

- Application opens from the month of June and close on July/August of every calendar year.
- Notice/advertisement is issued in Local Newspaper and website and or through Social Media.
- Application can be submitted on-line only at the institute website; itimizoram.in
- Required information- schedule of activities, available trades, Training calendar training session etc. can be obtained from the website and office of the Principal of the respective ITI.

ADMISSION PROCEDURE

- Selection of candidates for admission is done by counselling. Screening test (Written) is also conducted if required, according to the number of applicants in particular trades.
- Schedule of counselling and other screening test, if any, is fixed later as per the no. of application received which will be informed to all applicants through website, E-mail and or telephone and message.
- Application in prescribed format for Hostel facilities is received off-line only at the Principal office.







- For selected trainees only on a date to be specified later. (Application form can be obtained from Principal's office)
- Required document to be submitted along with application will be notified in the website.

ALL INDIA TRADE TEST (AITT)

Directorate General of Training(DGT), Ministry of Skill Development & Entrepreneurship (MSDE), Govt of India conduct the examination- All India Trade Test Annually Pan India for all National Council for Vocational & Education Training (NCVET) affiliated trades of ITI in Computer Based Test (CBT) mode for theory paper in all Nodal ITI exam Centres along with practical exam. Likewise, State Trade Test (STT) is also conducted for Mizoram Council for Vocational Training (MCVT) affiliated trades in ITI, if any, in the same mode.

Schedule of AITT/STT: AITT/STT is conducted annually during the month of July/August every calendar year. The concerned authority issue detail schedule of examination a month prior to the scheduled date.



Eligibility for Regular candidate:

- Trainees in ITI who complete 80% attendance both in theory and practical classes and whose conduct are found satisfactory during the training are eligible to appear in the annual & final trade test. And
- Trainees who score the prescribed internal marks (formative assessment) over the whole training period.
- Trainees who paid examination fees for both theory and practical.

Eligibility for Private candidate:

SCVT Certificate holder who has received institutional training in the same trade with the same duration of training period and entry qualification and on payment of fees.

 Apprentices under the Apprentice Act 1961 who have failed six times in the All India Trade Test for the National Apprenticeship Certificate can appear as private candidate in the corresponding trade under CTS only.

NATIONAL TRADE CERTIFICATE (NTC) & STATE TRADE CERTIFICATE(STC): Successful candidates in All India Trade Test& State Trade Test are awarded National Trade







Certificate (NTC) & State Trade Certificate (STC) respectively by NCVET and MCVT.

RESERVATION OF SEATS IN ITI


As per Training Manual for Industrial Training Institutes (as updated on Jan 2014) reservation of seats are provided as follows-

- 30% seats horizontally reserved for female candidates in each category (if unfilled, can be filled up by male candidate)
- Candidates sponsored by recognized orphanages shall be given preference.

3% for differently abled candidates having aptitude

- 3% for differently abled candidates having aptitude and otherwise fit to undergo training.
- 10 seats in each ITI for Ex-Servicemen, children of defence personnel and Ex-Servicemen.

Note: Reserved seats can be filled up by general candidates if unfilled by reserved candidate





DECLARATION OF RESULT

Result of All India Trade Test is declared approximately a month after conclusion of the examination and the candidates are directly informed through their e-mail.

CONVOCATION

Convocation /Graduation Day ceremony is held on a particular date as notified by DGT, MSDE during the month of September/October after declaration of result.

COUNSELLING & PLACEMENT CELL

Counselling & Placement Cell is established in ITI which is responsible in conducting Campus recruitment and other placement activities for the existing and pass out trainees, Record keeping and update etc.

INDUSTRY PARTNERSHIP

In an effort to make ITI students industry ready and to upgrade the ITI infrastructure, equipment and to improve training quality, the institutes have partnership agreement with-

ACADEMIC PARTMERSHIP

INSTITUTE MANAGEMENT COMMITTEE (IMC)

Every ITI has its separate Institute Management Committee (IMC) comprising of Chairman from Industry Association, Principal of ITI as Member Secretary and other member from officer of LESDE Department. Academician from University / Colleges and Industrialists. IMC is a registered Society under 'The Mizoram Societies Registration Act 2005' established by the State Government and is responsible to management of ITI

TRAINEES UNION

The Institute usually have Trainees Union at Institute Level with an objective to take efforts for the welfare of the Students/Trainees as well as to take part in the progress of the Institute at various levels.

INDUSTRIAL TOUR

Being part of the curriculum, the trainees of ITI regularly have Industrial visit/tour both within the state and/or outside the state once in an academic session.
