ADMISSION NOTICE.

In pursuance to the Technical Education & Skill Development Department UT Ladakh Admission Notification Issued vide No.: M/153/2021-SD&TE SECTION/2593-2610 Dated:-19/06/2024. Online Applications are invited from 20th June 2025 to 20th July 202. The desirous candidates for seeking admission in Govt. ITI Leh for the academic session 2025-26/27 in various Engineering/ Non Engineering Trades having duration of two years/one year being run under NCVT Scheme for which the forms can be uploaded from 20th June 2025 to 20th July 2025. The academic session shall commence from 1st August 2025.

Candidates having attained a minimum age of 14 years as on 1st June 2025, with no upper age limit can apply. The desirous candidates have to fill up the admission forms online on the link https://lsdm.ladakh.gov.in/iti-admissions/ available on the official website of Ladakh Skill Development Mission (https://lsdm.ladakh.gov.in/) under the ITI Admissions 2025 section.

The details pertaining to the trades functioning in Govt.ITI Leh which admissions are to be made for the session 2025-26/27 is available in the portal the same is detailed as under:-

The candidates have to fill up the complete details like name, parentage, qualification etc. online in the portal and have to upload the soft copies of the following documents on the portal:

- 1. Marks certificate of qualifying examination
- 2. Date of Birth Certificate.
- 3. Category Certificate (SC/ST/Ex-servicemen/EWS/PWD) if any.
- 4. Aadhaar card.
- 5. Domicile Certificate/ Residence Certificate should be produce at the time of admission in the ITI Leh.

The candidate, after finalizing the profile and application online will be required to submit the print out of the system generated application in this office in which the candidates in applying, along with self attested photocopies of the above mentioned required documents and the applicable application fee.

The candidates have to Pay a fee of Rs.100/- (One hundred) for up to three trades in which he/she is seeking admission against a cash receipt from Govt.ITI Leh. An additional amount of Rs.50/- per trade will be charged if a candidate selects an option of more than three trades in an application form.

The seats in any reserved category that cannot be filled due to a lack of candidates belonging to that category shall be filled by candidates from the General Category in order of their merit.

Important Notice:

- 01. Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination.
- 02. On successful completion of training in trades running under the NCVT scheme, certificate will be awarded by the National Council for Vocational Training.
- 03. Candidates who have already undergone training in any of the trades in any ITI can apply for admission in another trade after two years of completing the previous training course. However, for the ensuing academic session, their admission can be considered in any trade having a poor response.
- 04. First preference for admission in all trades will be given to residents of UT Ladakh Candidates belonging to other States/UTs will be considered for admission only if seats remain vacant after considering the applications of residents of Ladakh UT.
- 05. Candidates shall ensure to maintain a unique mobile number and email address. (in case of selection) till completion of the course and receipt of the certificate, as on change is permitted later.
- 06. Eligibility of PWD for a particular trade shall be as per DGT Norms/latest syllabus of DGT.
- 07. For the trades with an entry qualification of 8th passed, the candidates need to enter and upload 8th class marks in the online portal. If a candidate cannot produce the 8th marks card due to any reason, he/she enter and upload the 10th Class Marks/Mark sheet on the portal. The merit for the trades with 8th passed eligibility will be formulated on the basis of marks obtained by the candidate in 8th Class/10th Class.
- 08. A help desk for admission will be provided to the students with the facilities to fill out online applications, print the application form, and submit the application form.

Hostel facilities for Boys and Girls are available in the institute.
