- 4) Though E-verification of the document has been done, the Admitting College/ Institute/ Department should get original documents of the candidates verified minutely and matched with the documents uploaded by the Candidate. If any discrepancy is observed the candidate be guided to edit the CAP application form before Round III
- 5) In No case the Merit is to be violated
- 6) Candidates against whose names remarks are mentioned in column No 15, it is obligatory on the part of the Admission Seeking Candidate and the admitting College / Institute / Department to compel the discrepancy and then confirm the admission.
- 7) All procedure detailed in the CAP Information Brochure is to be followed scrupulously. Subject specialization the qualifying degree is to be minutely scrutinized while confirming admission
- 8) If any discrepancy in the data if observed by the candidates, the candidate should edit their CAP application form during the Grievance Period as per the Schedule and again submit their CAP Application form
- 9) The marks on which Class/Grade and Degree has been awarded has to be considered for verifying the qualifying degree marks
- 10) Admitting Colleges/Department should check the qualifying marks and the subject specialization of the Candidate in the Qualifying degree.
