**Subject: Conduct of Mop-up Round of Counselling/Submission of Online Preferences by the eligible candidates for admission to B.E./B.Tech. Courses-2025.**

## **Notification No. 090-BOPEE of 2025 Dated 07-08-2025**

Pursuant to Notification No. 078–BOPEE of 2025 dated 21-07-2025, the Board has received a shortfall from both the Government Engineering Colleges of the UT of J&K. To fill up these shortfall seats along with the seats which have become available due to non-joining and non-willingness for upgradation, resignation/surrender or remain vacant during 1st and 2nd round of counselling, it is hereby notified for information of all concerned candidates that the Board shall conduct the Mop-up round of counselling for only Government Colleges/Institutions w.e.f. **08-08-2025** (03:00 P.M. onwards) to **10-08-2025 (Midnight)**.

**The following procedures shall be adopted in this Mop-up round of counselling:**

1. The category seats which remain vacant even after the upgradation/allotment during the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> rounds, the same shall be de-reserved and filled up from all candidates through online mode of counselling in terms of Proviso to sub-section 2 of section 9 of J&K Reservation Act 2004.
2. The revised seat matrix shall be notified accordingly by the Board, and candidates willing and eligible to participate in the Mop-Up Round of counselling shall be required to fill in preference forms against the seats being notified. However, after conversion of category seats into General Seats, any seat(s) left by Reserved category candidates shall be treated as General/ OM category seats and will be allotted to any category (OM/Reserved) candidate(s) based on merit-cum preferences.
3. The seats in the “OM” which have remained vacant on conclusion of the earlier rounds shall also form part of the seat matrix and shall be filled up during the process out of all available eligible interested candidates based on merit-cum-preferences.
4. The seats which shall become available due to non-joining, resignation/ surrender/upgradation or remain vacant during the 1<sup>st</sup> /2<sup>nd</sup> / 3<sup>rd</sup> round shall also be added to the seat matrix and uploaded on the BOPEE website.

**The following candidates shall be eligible to participate in the 3<sup>rd</sup> round of Online (Upgradation/Allotment) Counselling:**

- 1) Candidates who did not get any seat in the 1st / 2nd / 3rd round.

- 2) Candidates who have been allotted a seat during the 1<sup>st</sup> / 2<sup>nd</sup> / 3<sup>rd</sup> round and have joined the College/Institution and have submitted their willingness for upgradation.
- 3) Candidates who have been allotted a seat during the 1<sup>st</sup> / 2<sup>nd</sup> / 3<sup>rd</sup> Round but could not join due to any of the reasons like deficient/invalid documents, non-submission of fee, non-reporting for admission, etc.
- 4) Candidates who have resigned by or before the last date of admission of the allotted seat of First/ Second/Third Round at the College/Institution.
- 5) The eligible candidates who have qualified for the B.E./B.Tech. Entrance Test-2025 and have not participated during the 1<sup>st</sup> / 2<sup>nd</sup> / 3<sup>rd</sup> Round of counselling are also eligible to participate in this round of counselling. They must submit the counselling fee of Rs. 1000/- and fill the preferences for the mop-up Round of Counselling.

**Important Note:**

- i. The candidates who do not participate in the process of counselling by not filling in the fresh preference forms shall in no case be considered for allotment of a seat, and they shall have no claim whatsoever on any seat filled up by the Board from amongst the candidates who participate in the process.
- ii. The candidates who have paid the online fee during the 1<sup>st</sup> / 2<sup>nd</sup> / 3<sup>rd</sup> round shall not be required to pay any fees during this round of counselling.
- iii. Candidates must consider available seats thoroughly and opt for such seats for which they are interested because the Seat once allotted cannot be changed. **It is made clear that if the candidate who has been allotted a seat but does not join the allotted college/institution and/or fails to comply with necessary formalities, his/her admission shall be cancelled and they will not be eligible for any further round of counselling, if conducted.**

The seat matrix shall be uploaded separately as per the schedule referred above, and all the participating/eligible candidates are advised to go through the seat matrix before participating in the counselling process.

The other terms and conditions shall remain the same as notified by the Board in the e-Information Brochure and Notifications/Notices issued from time to time in this regard.
