- 1) Online Registration starts on 28th August 2025, Thursday from 3.00 p.m.
- 2) Last date of Registration without late fee is 8th October 2025, Wednesday up to 6.00 p.m.
- 3) Last date of Registration with late fee is 15th October 2025, Wednesday up to 6:00 p.m.
- 4) Hall tickets will be made available to download under your respective member login by 30<sup>th</sup> October 2025, 6:00 pm.
- 5) To appear for November 2025 Online Examination, all applicants shall be required to fulfil the following mandatory technical requirements:

### 2. CS1, CS2:

- a. MS Office (Licensed)- 2010 or above
- b. R version 3.6.1 or higher
- c. R Studio Version 1.1 or higher for 32-bit operating system
  Version 1.2 or higher for 64-bit operating system

### Unlicensed MS Office and Office 365 is not allowed

Note: Any modifications to the above technical requirements will be notified by the Institute.

We urge all applicants to meet all mandatory technical requirements before registering for the November 2025 Online Examination. No requests for cancellation and refunds will be entertained post registration.

- 6) Institute will issue the "Student Guide for Actuarial November 2025 Home Based Online Examination" for detailed 'know how' of the online examination shortly.
- 7) Institute plans to conduct multiple mock examinations for all registered candidates. This will enable the candidate to confirm if their system meets the technical requirements as stated above. It will further help the candidate to get acquainted with exam software and processes. It is mandatory for the candidates to appear at least one mock exam of every registered subject to avoid last minute hassle. The detailed information will be communicated once registrations are closed.
- 8) You are advised to use your registered email id for all the communications related to examination.
- 9) All examination related details will be available in the Member Login and will also be communicated on your registered email ID at least 2 days before the date of examination.

### The procedure for the online registration of examination:

- Log on to your member login (<u>www.actuariesindia.org</u>) by entering your login ID and Password. Once you login, the system will ask you to upload your passport size photograph, telephone number and email id before moving further.
- 2) Click on the "Examination" -> "Examination" -> "Exam Registration Form" tab.
- 3) Click on "Register" button -> "Points to Remember" -> "Confirm & Next".
- 4) Confirm "Personal Details" -> "Confirm & Next".
- 5) Enter/Select "Country", "State" and "City" -> Confirm & Next.
- 6) Examination details -> Select the subject(s) you wish to appear in the check box.
  Note: You will only be able to register the subjects for which you have purchased the study material, and you can select multiple subjects in one examination session that do not fall on same date and time.
- 7) To register for additional subject, click on "Add" button -> Confirm & Next.
