Dear Candidate,

We hope that you have downloaded the Admit Card and are now fully prepared to appear for the JEE (Main) - 2026 Session 1 Examination on the **date, shift, course and venue of the test centre as indicated on the Admit Card** downloaded from the NTA website <https://jeemain.nta.nic.in/>.

Kindly keep in mind the following:

1. Please check the following as indicated on the Admit Card:
 - Date of Examination
 - Shift and Timings of Test
 - Venue of Test
 - **Reporting Time at Centre**
 - **Gate closing time of the Centre**
2. You should visit the Examination Centre in advance to familiarize yourself with the location and means of reaching the venue of the Test on time.
3. **Candidates were provided an option to register through Aadhaar. Those candidates who did not register through Aadhaar (or chose authentication through non-Aadhaar options), need to report early on the day of the examination (at least 1 hour before the gate closing time) to get their biometrics recorded at the Exam Centre.**
4. On the day of the Examination, several pre-examination formalities need to be completed; therefore, please arrive on time. Please reach the venue of the Test at the **reporting time** mentioned in the Admit Card. **If you report beyond the gate closing time of the Centre, you will not be allowed to enter the Test venue.** Instructions have been issued for strict compliance.

No candidate should adopt any unfair means, or indulge in any unfair examination practices as the examination centres are under surveillance of CCTV and equipped with Jammers.

5. Important documents / items to carry on the day of examination:

- Admit Card downloaded from the NTA Website (a clear, preferably colour printout on A4 size paper).
- Candidate must carry at least two passport photographs. One Passport size photograph (same as uploaded with the Online Application Form) is to be pasted on the Attendance Sheet at the Centre.
- A valid Photo ID Proof as uploaded in online application form in ORIGINAL. Photocopies or images stored on mobile phones etc. will NOT be accepted.
- (Note: No Candidate will be allowed to enter the Examination Centre, without identity verification).**
- Candidates whose live photographs did not match with the photographs available in their Aadhaar during the filling of the application form or those who registered using any other identity proof must carry the requisite certificate in original duly signed/attested by the Principal /Head Master or any Class-I Gazetted Officer, such as Tehsildar, Revenue Officer, SDM, DM / Class-I Gazetted Officer of the Indian Embassy (for NRI candidates), as per format shared in their registered email ID and notified vide NTA Public Notice dated 02 January 2026.
- PwD/PwBD certificate (If applicable):
 - PwD/PwBD certificate/UDID card issued by the Competent Authority, if claiming the relaxation under the PwD/PwBD category. Candidates with Physical Disability are requested to report early for facilitation during entry.
 - The facility of the Scribe will be provided, if the candidate has a physical limitation and a scribe is essential to write the examination on his/her behalf, being so certified in the prescribed format by a CMO/Civil Surgeon/ Medical Superintendent of a government healthcare institution. In case of persons with benchmark disabilities, in the category of blindness, locomotor disability (both arm affected-BA) and cerebral palsy, the facility of scribe/reader/lab assistant shall be given, if so desired by the person
 - The facility of Scribe will be provided to the PwD/PwBD candidates only if the candidate has opted for the same in the online Application Form of JEE (Main) - 2026.
 - A PwD candidate (having a physical limitation to write) *who is eligible to avail the facility of Scribe* will be allowed compensatory time of 20 minutes per hour of the examination.

6. Candidates are advised to ensure that their Aadhaar biometric authentication is not locked on the day of the examination. This is essential to facilitate a smooth and uninterrupted Aadhaar-based biometric verification process at the designated examination centres.

7. The candidate must enter the required details on the attendance sheet in legible handwriting. They should put their signature, Left Hand Thumb Impression and paste the Photograph at the appropriate place during the examination. They should ensure that their Left-Hand Impression is clear and not smudged.
8. Candidates may also note that the Examination will be computer-based and hence they should familiarize themselves.
9. The candidate should ensure that the Question Paper available on the computer screen is as per his/her opted subject/medium indicated in the Admit Card. In case, the subject/medium of the Question Paper is other than his/her opted subject/medium, the same may be brought to the notice of the Invigilator concerned.
10. For the Drawing Test—Part III of B. Arch., the candidate must bring their own Geometry Box Set, Pencils, Erasers, and Colour Pencils or Crayons. The candidates are not allowed to use watercolours on drawing sheet.
11. Candidates are **NOT** allowed to carry Instrument/ Geometry/ Pencil box, Handbag, Purse, any kind of Paper/ Stationery/ Textual material (printed or written material), Eatables and Water (loose or packed), Mobile Phone/ Ear Phone/ Microphone/ Pager, Calculator, DocuPen, Slide Rules, Log Tables, Camera, Tape Recorder, to wear/carry any type of watch including Electronic Watches with facilities of calculator, any metallic item or electronic gadgets/ devices in the Examination Hall/Room. There may not be any provision for safe keeping of valuables at the Centre.
12. **Diabetic students will be allowed to carry eatables like sugar tablets/fruits (like bananas/apples/oranges) and transparent water bottles** to the Examination Hall/Room. However, they will not be allowed to carry packed foods like chocolates/candy/sandwiches, etc.
13. **Apart from the biometric attendance and frisking at entry, if a candidate goes for bio-break/toilet, he/she should undergo the mandatory frisking and biometrics again.**
14. **Blank paper sheets for rough work of A4 size will be provided in the examination Hall/Room. Candidates must write their name and Roll Number at the top of each of the sheets and must drop the sheet(s) in the designated drop box without fail, before leaving the Examination Hall/Room. Failure to do so may result in a non-evaluation of your answers.**
15. **Duly filled-in Admit Card must be dropped in the designated Dropbox while leaving the Examination Hall/Room. Failure to do so may result in non-evaluation of your answers.**
