ORDER:

In the G.O. 1st read above, Government have issued orders declaring 20.3.2026 (Friday) as General Holiday on the occasion of Eid-UI-Fitr (Ramzan) under Negotiable Instruments Act, 1881 for the year 2026.

In the letter 2nd read above, the Chief Executive Officer (FAC), Andhra Pradesh State Waqf Board, Vijayawada, has submitted the General Holiday for Eid-UI-Fitr (Ramzan) is likely to be observed on 21-03-2026, based on the sighting of the moon, instead of 20-03-2026 as indicated in the Government Calendar and requested that the General Holiday for Eid-UI-Fitr (Ramzan) be rescheduled to 21.03.2026 in place of 20.03.2026 and solicited favorable orders.

The Government. after careful consideration of the matter, have decided to change the General Holiday on the occasion of Eid-UI-Fitr (Ramzan) on 21.03.2026 (Saturday) instead of 20.03.2026 (Friday). Accordingly, the following notification is issued and shall be published in the extra- ordinary Gazette of Andhra Pradesh State:-
